**NAME OF WORK: Procurement of 33/ 220 kV 100 MVA (3 nos.) Step-up Power Transformers for power evacuation of 250 MW (1X250 MW) Grid- Connected Solar Photo Voltaic Project at Suwasra, Dist- Mandasaur, Madhya Pradesh**

1. Government of India (GOI) *intends to apply for a loan* from the World Bank towards the cost of Proposed Power Evacuation Scheme for 250 MW, Solar Power Project at Suwasra, Distt. Mandasaur. It is intended that part of the proceeds of this *loan* will be applied to eligible payments under the contract for the procurement of the various items/ materials required for proposed power evacuation scheme through National Competitive Bidding procedure. Bidding will be conducted through single stage bidding procedures agreed with the World Bank for procurement of various items/ materials. Bidding is open to all eligible bidders as defined in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011, updated July 2014. Bidders are advised to note the minimum qualification criteria specified in Section III– Evaluation and Qualification Criteria of Volume-I of the Bidding Document, to qualify for the award of the contract.
2. The RUMS Limited, Bhopal, a joint venture of Solar Energy Corporation of India and Madhya Pradesh Urja Vikas Nigam, now invites sealed bids from eligible bidders for procurement of 33/220 KV, 100 MVA step up power transformers required for Proposed Power Evacuation Scheme for 250 MW Solar Power Project at Suwasra, District-. Mandasaur under Neemuch Solar Park in Madhya Pradesh on turnkey basis as detailed under:

Interested bidders may obtain further information at the same

address. Bidding documents requested by mail will be despatched by registered/speed post on payment of an extra amount of Rs. 200/ (Two hundred only). The Employer/MPPTCL will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.

4. Bids shall be valid for 120 days after the dead line for submission of bids.
5. Bids must be accompanied by Bid security of the amount of Rs 42,53,000/ (Forty two lacs, fifty three thousand only) as specified in Bidding Document (Bid Data Sheet) in favor of RUMS Limited, Bhopal. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 28 days beyond the validity of the bid.
6. Bids complete in all aspect should be addressed to Chairperson, RUMS Limited, Bhopal must be delivered to the office of Chief Engineer (Procurement), Block No. 3, Shakti Bhawan, Rampur, Jabalpur (M.P.), 482008 (Project Management Consultant of RUMS, Limited, Bhopal) on or before 1500 hours on **05.07.2016** and Bid will be opened on the same day at 1600 hours, in the presence of the bidders who wish to attend. Late bids will be rejected. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
