Sub: - Minutes of online pre-bid meeting held on 04/07/2022 and 08/07/2022 for Standardization of Rates and Selection of Contractors for Solar Rooftop Projects at various locations in Madhya Pradesh.

Ref: RFP No. F/UVN/2022/RFT/01-373/1593, Dated: 21/06/2022

This is with reference to the above referred RFP floated for Design, Engineering, Supply, Installation, Testing and Commissioning Including Insurance, Warranty, Spare Parts and Operation & Maintenance of Grid Connected Roof Top Solar PV Projects with/without Energy Storage and Off-Grid Roof Top Solar PV Projects with Energy Storage at Various Locations in the State of Madhya Pradesh.

The first pre-bid meeting for the tender was held online on 04/07/2022, wherein an overview of the RFP was given to the bidders, followed by discussions on bidders' queries. Subsequently, a second online pre-bid meeting was held on 08/07/2022 for discussion on the RFP and addressing bidders' queries and concerns. Some of the bidders also have submitted their concerns and queries through e-mail. Bidders' queries have been noted and issue-wise minutes of meeting are given below:

1. It was clarified that in case of ground mounted projects (off-grid and grid connected), civil work for the foundation of solar panel mounting structures below ground level (GL) will be payable as per clause no. 2.5.2 of the RFP.
2. Technical eligibility criteria will be considered for last five (5) years, i.e. work order and its completion certificates from FY 2017-18 under the different categories will be considered for evaluation. Further, projects executed in Market Mode will also be allowed for technical evaluation but the bidder will have to submit the certificate(s) of successful installation and commissioning of the project(s), clearly indicating total executed capacity and min-max size of the system, issued by concerned DISCOM/State Nodal Agency
3. It was clarified by MPUVNL that O-PBG of 10% (grid connected systems) and 15% (off-grid systems) will be returned only after satisfactory completion of 5 years of Comprehensive Operations and Maintenance Period, and the O-PBG will not be returned on an annual basis.
