**Sub: - Minutes of online pre bid meeting of RfP for setting up of Grid connected Solar PV based Power Plants (SPP) under feeder solarization component of PM KUSUM - C Scheme for sale of power to MPPMCL- - reg.**

This has reference to above referred RFP for "Selection of Renewable Power Generators for Setting up of Grid connected Solar PV based Power Plants (SPP) under feeder solarization component of PM KUSUM - C Scheme for sale of power to MPPMCL". About 30 potential bidders participated in pre-bid meeting on 27 January 2023 organized online. Some of the bidders also have submitted their concerns and queries through e-mail.

Bidders put queries during online pre-bid meeting and those were replied appropriately. Further, some bidders have submitted their concerns and queries through e-mail. Some major concerns are minutized as below:

### 1. Provisions related to bidders as consortium/ JV

In line with Cl. 3.14.5 (1) and Cl. 3.14.4 (g), bidders participating as consortium are allowed to meet financial eligibility criteria jointly through members of consortium. Accordingly, Cl. 3.14.1 (c) may be read as:

*"Bidder or members of Bidding consortium/ JV, in case of Consortium/ JV, should meet networth OR turnover criteria required under the RfP."*

In line with above, header of first column in 1<sup>st</sup> table of Format D6: Financial Eligibility Criteria Requirement" is corrected and shall be read as- "Name of Entity being evaluated"

Further, Cl. 3.14.1 (b) of RfP is amended as:

*"Bidder can form a Bidding Consortium/ Joint Venture of two (2) Companies or LLPs or Partnership Firms or Sole Proprietors or any combination thereof".*

According to above, all other related and relevant provisions of RfP and PPA and their corrigenda, if any, stand amended/ modified/ aligned as far as provisions related to bidders participating as consortium/ JV are concerned.
