Standard Operating Procedure (SOP) for Vendor Registration under PM Surya Ghar: Muft Bijli Yojana

Objective:

To outline the step-by-step procedure for vendor registration under the **PM Surya Ghar: Muft Bijli Yojana**, ensuring compliance with state DISCOM norms and national portal requirements.

Scope:

This SOP applies to all vendors intending to participate as **Subsidy Vendors** under the PM Surya Ghar Yojana in Madhya Pradesh and must be adhered to strictly for successful registration.

Prerequisites:

- Vendor must be registered as a Non-Subsidy Vendor with the concerned DISCOM before applying for Subsidy Vendor status.
- A valid Bank Guarantee (BG) is to be prepared in favor of MPUVNL.

Procedure:

Step 1: Non-Subsidy Vendor Registration (Pre-condition)

- Ensure that your firm is registered as a Non-Subsidy Vendor with the respective DISCOM(s) in Madhya Pradesh where you intend to operate.
- Follow the specific DISCOM's internal process for this registration.

Step 2: Preparation of Bank Guarantee (BG)

- Prepare a Bank Guarantee as per the specified format and amount directed by MNRE.
- The BG must be in favor of:
 Madhya Pradesh Urja Vikas Nigam Ltd. (MPUVNL)
 [Mention address and IFSC if needed]

Step 3: Submission of BG Hard Copy to SIA

 Submit the physical copy of the BG to the State Implementation Agency (SIA) for verification and further processing.

Step 4: Registration on National Portal

- Visit the official National Rooftop Solar Portal at https://pmsuryaghar.gov.in.
- Navigate to Vendor Registration section and fill in all required details.
- Upload all necessary documents including:

- PAN Card
- o BG
- o Service provider declaration (Annexure format available in national portal)
- Training Manpower credentials format (format available in national portal)

Step 5: Online Approval from SIA

- Once all documents are uploaded, the application will be forwarded to the SIA for approval.
- The SIA will review and verify the documents.
- Upon successful verification, vendor status will be updated as Registered Subsidy Vendor on the portal.
